

China Product Standard FZ/T 73020-2019 Knitted Casual Wear Technical Parameters Comparison to the 2012 Version

FZ/T 73020-2019 Knitted casual wear was recently published. It is applicable to knitted casual wear mainly made of knitted fabric for children and adults. It is not applicable to infants clothing for age of 36 months or under. It will be effective as of July 1st 2020. In comparison to FZ/T 73020-2012, major technical parameter changes are the following:
