

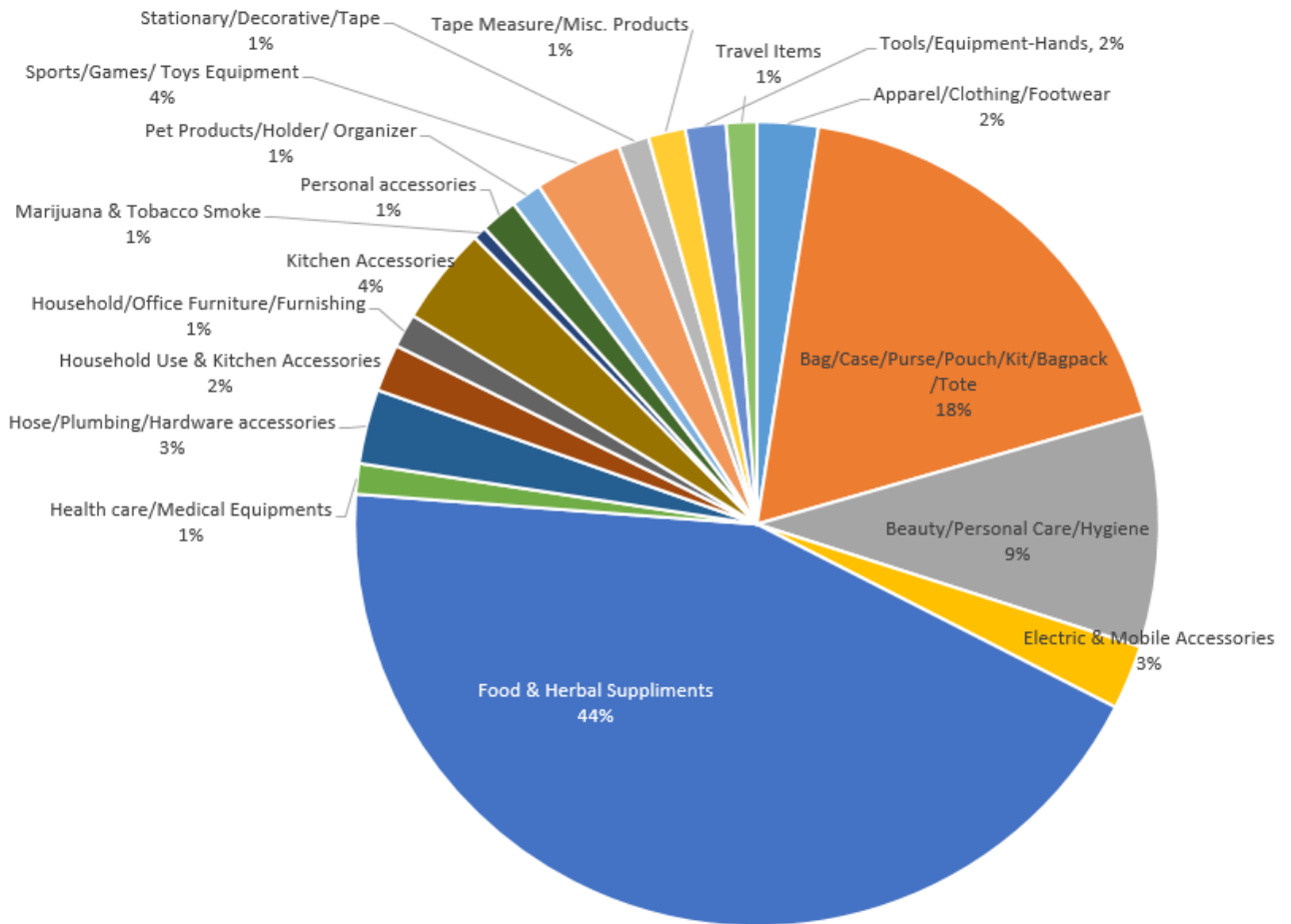


CA Proposition 65: 60 Day Notice Summary for Q4 2021

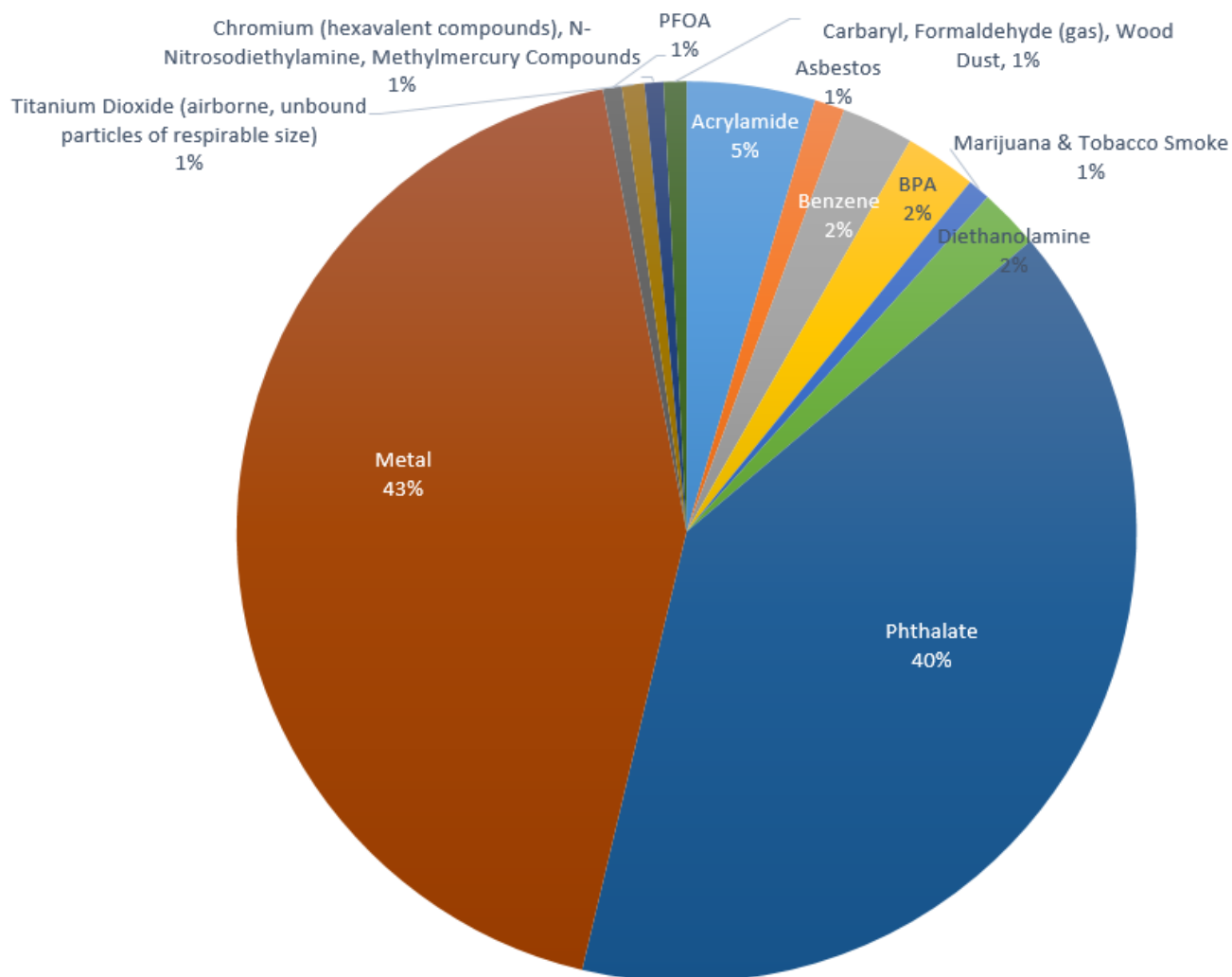
Enforcement Trends:

- The highest amount of notices by product category was for food and herbal supplements, which accounted for 44% of all 60 Day Notices. Of those notices: 191 were for lead, 33 for acrylamide, 31 for cadmium, 6 for arsenic, 4 for DEHP, 1 for methylmercury, 1 for carbaryl, and 54 for two or more chemicals.
- Bags, cases, etc. accounted for 18% of all notices this quarter. Of those, the majority were for phthalates (including 109 for DEHP, 10 for DINP, 2 for DIDP, 2 for DBP and 5 for more than one phthalate). However, there were also one each for BPA, cadmium, lead, titanium dioxide and wood dust.
- 43% of all notices were for metals: 227 for lead, 32 for cadmium, 6 for arsenic, and 54 for two or more metals. The notices covered several product categories.
- 40% of all notices were for phthalates: 229 were for DEHP, 46 for DINP, 2 for DIDP, 9 for DBP and 8 for two or more phthalates. The notices covered a range of products.
