

China Recall of Hardgoods and Juvenile Products from January to March 2022

From January to March 2022, according to the disclosure of product recall news from China SAMR Defective Product Administrative Center, the products involved in recalls for this period include children's scooters, strollers, toys, children's beds, bookshelves, nightstands, chairs, mattresses, school bags and tooth brushes. See the table below for details.

1	Children's vehicles	Twisting skateboards	The thickness of plastic bag or plastic film, the clearance between moving parts, and plasticizer content of the product do not meet the requirements of GB 6675.1-2014 and GB 6675.2-2014.	It's harmful to consumer's health together with suffocation risk from the plastic bag.
		Strollers	Durability performance of the product does not meet the standard requirements. The restraining system does not secure the children well.	The product is prone to rollover during use, which is easy to cause children to fall off and get injured.
		Scooters	The safety warning verbiage and signs on vehicle body are missing. The color of vehicle frames is similar to the color of warning sign, so the warning content is not obvious.	It may increase the safety risks such as misuse and abuse by consumers, causing harms to consumers like falling off.
2	Toys	Plush toys	Warning signs and small parts do not meet standard requirements.	There is potential safety hazard of swallowing, choking and suffocation.
		Electrical toys	The product fails to provide consumers with warning and instruction of replacing batteries	The lack of warning signs and replacing battery instruction, which may lead consumer to misuse it and cause safety risks.
		Plastic toys	There are small balls or small parts that do not meet GB 6675.2-2014 standard requirement.	There is potential safety hazard of swallowing, choking and suffocation.
		Puzzle toys	The thickness of plastic bag does not meet GB 6675.2-2014 standard requirement.	There is potential safety hazard of suffocation.
		Pacifiers	The content of volatile compounds exceeds the limit.	It's harmful to consumer's health.
3	Children's furniture	Children's beds	There are protruding parts that may cause entanglement or entrapment by them. In addition, the use instruction of the bed rail is not clearly marked in use manual.	There is a risk of strangulation, and children rollover might occur if the rail is not being used properly, resulting in potential falling hazards.
		Children bookshelves	The connector and use method for fixing the product against the wall are not provided. Formaldehyde emission exceeds the standard requirement.	Bookshelf may collapse and cause harm to children, and excessive formaldehyde is harmful to consumer's health.
		Bed guardrail	Age grade and some warnings are not marked on the manual properly, or the warnings are incomplete.	These may cause consumers to ignore potential risks.
4	Furniture	Desks	The drawer is not equipped with locking device to prevent the drawer from slipping off	There is a potential safety hazard that the drawer falls off and injures hands and feet.
		Nightstands	The drawer is not equipped with locking device, and formaldehyde emission does not meet the standard requirement.	There is a potential safety hazard that the drawer falls off and injures hands and feet. Excessive formaldehyde is harmful to consumer's health.
		Mattresses	Formaldehyde emission does not meet the standard requirement.	Excessive formaldehyde is harmful to consumer's health.
		Chairs	Formaldehyde emission does not meet the standard requirement.	Excessive formaldehyde is harmful to consumer's health.
5	School articles	Schoolbags	The oscillation impact performance does not meet standard requirement.	There is potential risk that the carrying straps broken and may hurt consumer.
6	Other consumer goods	Tooth brushes	The tip of the bristle has not been polished to remove burrs.	There is risk to hurt consumer oral cavity
