

China Recall of Hardgoods and Juvenile Products from April to June 2022

According to the product recall news released from China SAMR Defective Product Administrative Center from April to June 2022, several products had been recalled. Details involved in recalls for this period are shown in below table.

| 1 | Children Vehicles | Push bikes | There is excessive phthalates in the cushion. | Due to excessive phthalates in the cushion of the push bike, it will cause harm to children and pose potential safety hazards. |
| | | Strollers | There are dangerous cracks, insufficient stability and wheel strength, unqualified flammability performance and wrong labeling information. | There are dangerous cracks, which may cause injury to children fingers. Insufficient stability and wheel strength may cause the vehicle to overturn during use, resulting in children falling. The unqualified flammability performance and wrong labeling information, which may have serious hazards. |
| 2 | Toys | Bubble toys | Plasticizer exceeds the standard requirement. | Excessive phthalates will cause harm to children and pose potential safety hazards. |
| | | Plush toys | There are small balls as small parts that do not meet GB 6675.2-2014 standard requirement. | There is potential safety hazard of choking and suffocation to young children. |
| 3 | Children furniture | Children beds | The size of the hole is bigger than required dimension, and the height of the guardrail is too low. | There are potential safety hazards of injuries from entrapment and falling. |

| 4 | Furniture | Night stands | The formaldehyde emission does not meet the standard requirement. | Excessive formaldehyde is harmful to consumer's health. |
| | | TV stands | The formaldehyde emission does not meet the standard requirement. | Excessive formaldehyde is harmful to consumer's health. |
| 5 | Stationery and sporting goods | Student notebooks | There is sharp point, and the paper brightness performance does not meet the requirement. | Students may have their fingers lacerated when using. The high brightness of paper will harm the vision of users from prolonged use. |
| | | Pencil boxes | Plasticizer exceeds the standard requirement. | Excessive phthalates will cause harm to children and pose potential safety hazards. |
| | | School bags | Heavy metals exceed the standard requirement. | Excessive heavy metals will cause harm to children and pose potential safety hazards. |
| | | Plastic footballs | Plasticizer exceeds the standard requirement. | Excessive phthalates will cause harm to children and pose potential safety hazards. |
| | | Pens | Air hole on cap of pen does not meet requirement. | There is risk of suffocation if swallowed by children. |
| 6 | Other consumer goods | Puzzle floor mats | There are small parts. | There is potential safety hazard of choking and suffocation to young children. |
| | | Travelling cases | The travelling case is deformed and broken when tested. | The product deforms and breaks during use, which may cause harm to consumer. |
