CA Proposition 65 – 60 Day Notice Summary for Q3 2019

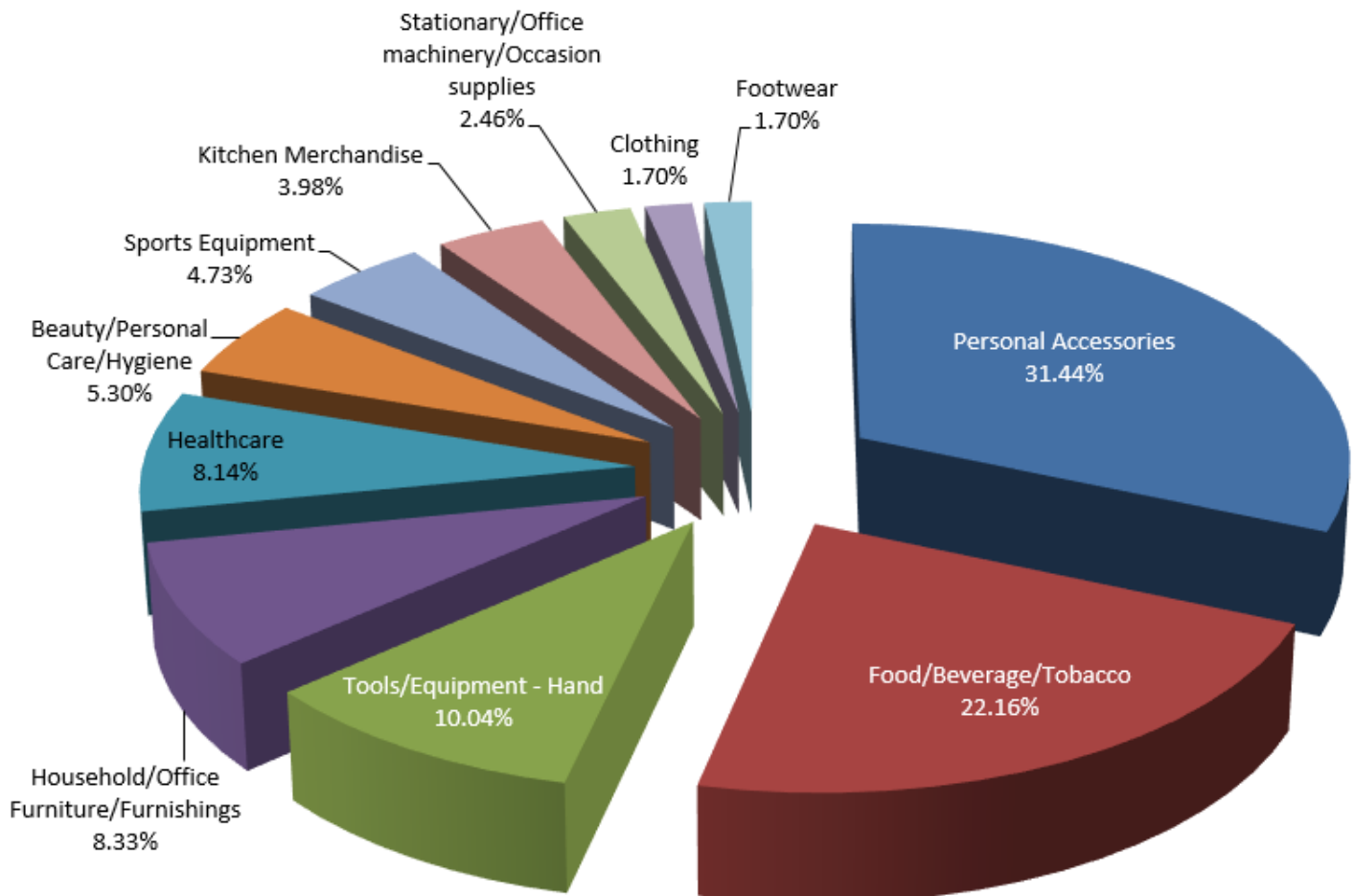
October 2019

ENFORCEMENT TRENDS

- Significant increase in Personal Accessories (>12%), Food/Beverage/Tobacco (4%) and Tools/Equipment-Hand (7%).
- Phthalates continue to be the main focus for enforcement in Q3, accounting for over 65% of sixty day notices issued.
- Several sixty day notices issued to chemical suppliers for raw chemicals being sold.

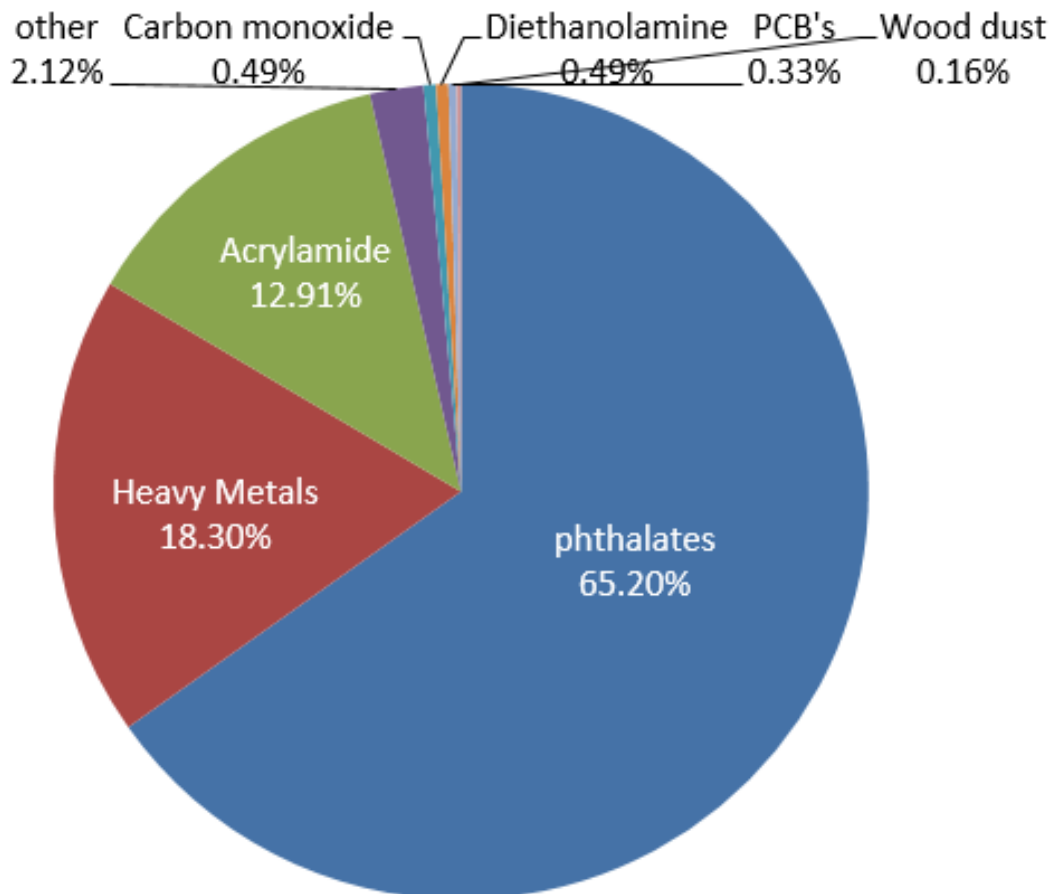
